



A. YOYOMOTION PRIVACY POLICY

Yoyomotion AB knows how our users care about how your personal information might be used and shared. Therefore, we take your concern seriously and we want you to be clear how we're using information and the ways in which you can protect your privacy.

This privacy policy relates to products and services, including pre and post sales support, provided by Yoyomotion AB under the name of Yoyomotion or trademarks registered by Yoyomotion AB.

We, depending on product, mobile application and service, collect information to provide better services to all of our users – such as to set up a user account, personal profile, sharing with other users etc. In order fulfill those services, we may store certain genres of personal information in our servers.

We collect information in three ways:

1. Information we collect:

For example, some of our services require you to sign up for a registration. Therefore, we will collect personal information such as your name, email address, IP address, your time zone, camera title and description. If you want to take full advantage of our sharing features we offer, we may also ask you to provide us with certain information to submit the service.

2. Information we get from Your use of our services:

We will automatically receive and record certain information from your app when you interact with our service, some of those automatically collected information may not be personal information depending on the service's nature.

When we collect usage information, we only use those data in aggregate form but not to identify you personally. For example, this aggregated data enable us to know how often customers use parts of our service, so we can make the service attractive to as many customers as possible. We may also provide this aggregated information to our partners to give them a clear picture of how often our users use our services; in that case, we can provide our users with an optimum online experience. However, we will never disclose aggregated information to a partner in a manner that would identify you or any other users personally.

3. Communication channels:

We may contact you, by email or other means; for example, we may send you promotional offers, or communicate with you about your use of our service. If you do not wish to receive any email from us, please indicate your preference by emailing us at info@yoyomotion.com.

When you choose to use our invitation service to invite a friend to the service, we will ask you for invitee's email address and send an email invitation automatically. We'll store this information to send this email, to register your friend when your invitation is accepted, and also to track the success of our invitation service. However, your friend may still contact us and request us to remove this information from our database at info@yoyomotion.com.

4. How we use information we collect:

We use the information we collect from our services to provide, maintain, protect and improve them, and to develop new ones. We will neither sell nor rent your personal information to anyone. We may only share non-personal information with third parties described below:

a. **Affiliated Businesses:**

In certain situations, our affiliated businesses may sell items or provide services to you (either by themselves or jointly with us). For example, when we sell products or provide services jointly with affiliated businesses we may share non-personally identifiable information (such as anonymous usage data, URLs, platform types, number of clicks, etc.) with interested third parties to help them understand the usage patterns for certain Yoyomotion products and services.

b. **Advertisers:**

We may allow advertisers to share the demographic information of our users who will see their advertisements and we may provide information we have collected from you to an advertiser in non-personally-identifiable form, so the advertiser can select the appropriate audience for its advertisements.

c. **Agents and Resellers:**

When we partner with other companies and people to perform tasks on our behalf, such as sales, logistics or support, we will need to share your information with them to provide services to you. However, unless we tell you differently, our partners do not have any right to use any personal information we share with them beyond what is necessary to assist us. For example, for shipping a product to you we would need to allow a logistics company to use your personal data to perform the service. However, that company would only be authorized to use your information to the extent needed in completing the service.

d. **User Profiles and Submissions:**

Please understand that we cannot control what other users do with any content you voluntarily disclose to them through our service. For example, we will share your video content with users designated by you via the service, but we cannot control if users you have allowed access to make your user submissions publicly available or to be collected and used by others. Or to be redistributed through the internet and other media channels.

e. Protection of Yoyomotion AB and Others:

We may release personal information when we believe in good faith that release is necessary to comply with the law; enforce or apply our conditions of use and other agreements; or protect the rights, property, or safety of Yoyomotion, our employees, our users, or others. This includes exchanging information with other companies and organizations for fraud protection and credit risk reduction.

f. With Your Consent:

Except from what mentioned above, we will share your personal information with third parties only when we have your consent to do so.

5. Information security:

If the use of our product and service requires the registration of a personal account, your account will be protected by a password for your privacy and security. However, in order to prevent unauthorized access to your account and personal information, it's important to select and protect your password appropriately and also to limit access to your mobile phone and browser by signing off after you have finished accessing your account.

We strive to protect the privacy of your account and personal information we have in our records, but a complete security cannot be guaranteed. Unauthorized entry or use, hardware or software failure, and other factors, may still compromise the security of user information at any time.

We are not responsible for the privacy policies for other links the service contains. When following a link to another site you should read that site's privacy policy.

6. Accessing and updating your personal information:

When updating your personal information, we may ask you to verify your identity before we can act on your request. You may access, change or delete certain information you've provided to us or correct your account information and email preferences at any time by logging into your account.

The information you can view and update through your account may change as our service changes. For purposes of applicable law (e.g. GDPR), and if you have any questions about viewing, updating or deleting information we have on file about you, please contact us at info@yoyomotion.com.

7. Changes to the privacy policy

Our Privacy Policy may change periodically. We will not reduce your rights under this Privacy Policy without your explicit consent. We will update any privacy changes on the page and notify you about significant changes. Also, we will keep prior versions of this Privacy Policy in an archive for your review.
